

**Information for customer / supplier / client
ON PERSONAL DATA PROCESSING
pursuant to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of
27 April 2016, the General Data Protection Regulation (GDPR)**

(under Art. 13 (1) of the GDPR)

c) Purpose of the processing: Legal reason for processing:	(i) performance of contracts between the entity and the Administrator (ii) application of legal claims (iii) fulfillment of legal obligations (eg archiving) (iv) addressing potential customer / client within Marketing (v) purposes contained in the Consent to the personal data processing (i) performance of the contract or the implementation of measures taken before the conclusion of the contract (ii) fulfillment of legal obligation (iii) legitimate interests of the Administrator or a third party (iv) if no other title is given, then consent to the processing of personal data
d) Eligible interests of the Administrator or third party:	Processing of customer/client personal information for direct marketing purposes (offer of follow-up and / or other services and / or goods by the Administrator).
e) Category of personal data recipients:	(i) external tax adviser (ii) law office (iii) translation agency (iv) insurance company (v) public authorities
f) The intention to pass personal data to a third country or international organization:	The Administrator does not intend to.

(under Art. 13(2) of the GDPR)

a) The duration of the personal data storage:	In accordance with the deadlines specified in the relevant agreements, internal regulations of the Administrator or in the relevant legislation, the time limits specified in the relevant contracts, insofar as it is the time necessary to secure the rights and obligations arising both from the contractual relationship, as well as the legal regulation.
b) Rights of data subjects in relation to personal data - against the Administrator:	(i) require access; (ii) require the correction of inaccurate data; (iii) require deletion; (iv) require processing restrictions; (v) submission of objections against processing; (vi) require the portability of data.
c) The right to withdraw consent:	If processing is based on consent to processing, then the right to revoke consent is granted at any time, without prejudice to the lawfulness of the processing based on the consent given prior to its removal.
d) Right to file a complaint with the Supervisory Authority:	The data subject has the right to file a complaint with the supervisory authority, which is the Office for Personal Data Protection (www.uoou.cz).
e) Legal/contractual requirement to provide data and the consequences of failure	The provision of personal data is based on both contractual and statutory requirements. Failure to provide personal data may result, in particular, in a violation of law and/or the impossibility of entering into a contract.
f) Automated decision making / profiling	It is not being performed.
